



## Internet Acceptable Use Policy

---

### Purpose

The goals of this policy are to outline appropriate and inappropriate use of Countryside RV Park's Internet resources. As a guest, you and you alone are responsible for the content viewed and/or downloaded from the Internet.

### Your Guest Account

Each user of the Countryside RV Park system is required to read this Internet policy. Upon registering as a camper or visitor at the main office, you are also agreeing to comply with this policy, and your signature on the registration form constitutes legal acknowledgement of this policy. In the event that a camper has registered their visitors, they assume responsibility for the actions of their visitors.

### Appropriate Use

Individuals at Countryside RV Park are encouraged to use the Internet to further the goals and objectives of their individual employers or for recreational use. The types of activities that are encouraged include:

1. Communicating with fellow employees, business partners and clients within the context of an individual's assigned responsibilities;
2. Acquiring or sharing information necessary or related to the performance of an individual's assigned responsibilities; and
3. Participating in educational or professional development activities.

### Inappropriate Use

Individual Internet use will not interfere with others' productive use of Internet resources. Users will not violate the network policies of any network accessed through their account. Internet use at Countryside RV Park will comply with all Federal and Connecticut laws, and all Countryside RV Park policies. This includes, but is not limited to, the following:

1. The Internet may not be used for illegal or unlawful purposes, including, but not limited to, copyright infringement, obscenity, libel, slander, fraud, defamation, plagiarism, harassment, intimidation, forgery, impersonation, illegal gambling, soliciting for illegal pyramid schemes, and computer tampering (e.g. spreading computer viruses).
2. The Internet may not be used in any way that violates Countryside RV Park's policies, rules, or administrative orders including, but not limited to, any applicable code of conduct policies, etc. Use of the Internet in a manner that is not consistent with the mission of Countryside RV Park, misrepresents Countryside RV Park, or violates any Countryside RV Park policy is prohibited.
3. Individuals should limit their personal use of the Internet. Countryside RV Park allows limited personal use for communication with family and friends, independent learning, and public service. Countryside RV Park prohibits use for mass unsolicited mailings, access for non-employees or unregistered guests/visitors to Countryside RV Park resources or network facilities, uploading and downloading of files for personal use, access to pornographic sites, gaming, competitive commercial activity unless pre-approved by Countryside RV Park and the dissemination of chain letters.



4. Individuals may not establish Countryside RV Park company computers as participants in any peer-to-peer network, unless approved by management.
5. Individuals may not view, copy, alter, or destroy data, software, documentation, or data communications belonging to Countryside RV Park or another individual without authorized permission.
6. In the interest of maintaining network performance, users should not send unreasonably large electronic mail attachments or video files (or download same) not needed for legitimate purposes.

## Security

For security purposes, users may not share network account or password information with another person. Users must also remember that the Countryside RV Park network is an open, unprotected network, and shall take necessary precautions to safeguard hardware and personal information. Users must take all necessary precautions to prevent unauthorized access to Internet services.

## Failure to Comply

Violations of this policy will be treated like other allegations of wrongdoing at Countryside RV Park. Sanctions for inappropriate use of the Internet may include, but are not limited to, one or more of the following:

1. Temporary or permanent revocation of access to some or all computing and networking resources and facilities;
2. Immediate eviction from Countryside RV Park,
3. Legal action according to applicable laws.

## Monitoring and Filtering

Countryside RV Park does not monitor, and is NOT responsible for monitoring any Internet activity occurring on the Countryside RV Park network. Countryside RV Park currently does not employ filtering software to limit access to sites on the Internet. If Countryside RV Park discovers activities, which do not comply with applicable law or Countryside RV Park policy, records retrieved may be used to document the wrongful content in accordance with due process.

## Disclaimer

Countryside RV Park assumes no liability for any direct or indirect damages arising from the user's connection to the Internet. Countryside RV Park is not responsible for the accuracy of information found on the Internet and only facilitates the accessing and dissemination of information through its systems. Users are solely responsible for any material that they access and disseminate through the Internet.
